CONDITIONS:

1. The total standard/quotation amount must be paid in full prior to commencement of any work.
2. City will install services to the property line. The Owner will be responsible for connection from the building to the services.
3. Applicant is responsible for the payment of all costs associated with labour, equipment and materials supplied by the City including the cost for any repairs to the City owned sidewalk, street or lane.
4. City is not responsible for the replacement or repair of any surface improvements including grass, shrubs, trees, driveways, sidewalks, retaining walls, etc.
5. The City is not responsible for any property damage caused by water entering through the trench in which the connections are laid, repaired or replaced.
7. The City agrees to guarantee all workmanship and materials for the period of one full year following installation. This guarantee shall be void should damage to the service(s), within this year, be the result of undue care and attention by the property owner or contractors carrying out work for the property owner.
8. The Owner must ensure that the curb stop cap for the water service is kept level with all adjacent finished surfaces to allow access by City crews. As well, this valve cap must be protected from any damage. Should adjustments to this valve cap be required, the Owner shall contact Public Works at 778-2748.
9. The Owner shall be responsible for all maintenance to the water and sewer services immediately after their installation and shall have no right of action against the City at any time in the future.
