Notice of Motion for Bylaws to Establish the Mill Rate, Establish the Mill Rate Factors, Special Levy, and Exempt the 2023 Assessment of

Certain Properties

BACKGROUND

Every year, Council needs to approve and adopt various agreements and policies to exempt certain properties from taxation, as well as to set the uniform mill rate and associated tax policies.

DISCUSSION

This report deals with giving public notice, as required by *The Cities Act*, that the necessary bylaws to establish the mill rate, the mill rate factors, the special levy for the long-term care facility, as well as to exempt the assessment of certain properties, be brought forward at a future meeting of Council.

This year, the percentage of values stipulated by the Province of Saskatchewan will remain unchanged. The percentage of value is applied to the total assessed value of each property to determine the portion that is taxable. In 2023, the percentage of value by property class is as follows:

In addition, notification regarding the education property tax mill rates to be levied on all properties in the 2023 taxation year is forthcoming from the Ministry of Government Relations and Holy Trinity Roman Catholic Separate School Division No. 22. As has been done in past years, municipalities will collect public and separate education property taxes and remit the funds to the Province or the separate school division.

BACKGROUND

With a recent comparative review of the Rural Water Pipeline (RWP) connection fees, it was identified that the Swift Current RWP has the lowest connection fees in the Province. Currently, we recover only our cost to connect to the rural water system. The minimum connection fee for the Swift Current RWP is \$7,800, with \$2,600 of that sum remitted to the Rural Municipality of Swift Current No. 137 (RM) or the agreed allotment fee. Any additional construction fees above the \$7,800 are charged to the customer at cost.

DISCUSSION

Administration is recommending an increase of the minimum connection fee to \$10,000 with an additional \$2,600 charged for the RM allotment for a total minimum connection fee of \$12,600. In addition, the new subscriber would be responsible for any engineering and construction costs incurred. The \$2,600 allotment fee would be remitted to the RM, and \$10,000 would be put into reserves for future upgrades and maintenance to the Swift Current Rural Water Pipeline.

The establishment of the application and connection process, rates, and other information pertaining to the Swift Current Rural Water Pipeline will be set out by way of bylaw. Thereafter, fees will be reviewed on the same basis as other City utility rates in conjunction with Bylaw No. 17 - 2001, being the Water and Wastewater Utility Bylaw.

Ice Resurfacer Replacement

BACKGROUND

The purchase of a 2023 Electric Ice Resurfacer for the S3 Twin Arena's was approved in the 2023 Capital budget as a replacement. Of all the units in the fleet, the Ice Resurfacer at S3 Arenas receives the most use as it takes care of two (2) ice surfaces every day of the week throughout the season.

Ice resurfacers are a specialty piece of equipment with no local suppliers. The City of Swift Current has operated an electric resurfacer at the Innovationplex for the past two (2) years with terrific results.

New technology has improved the product with the cost of a flood by the electric unit being estimated at \$0.35 in comparison to a gas or propane unit of \$3.50 per flood. The cost per day savings would be \$37.80 and up to as much as \$10,206 per eight-month daily use.

DISCUSSION

RFP, CSC-23-R-043 was posted February 3rd and closed on February 17th, 2023. Unit P56, a 2011 Olympia side dump propane model, will be traded in for the purchase. It currently has 6659 hours. Three (3) suppliers submitted proposals for the RFP, pricing ranged from \$162,342.86 to \$212,013.40 (PST included, GST excluded).

The major reasons the Engo Ice Wolf scored higher were as follows:

- Highest Trade-in Value \$12,000
- Second lowest cost
- 3 year bumper to bumper warranty, 5 year warranty on battery, 2 year warranty on charging unit and 10 year bumper to bumper warranty on frame and axel
- 120 day delivery time frame compared to 1 year for the rest of the submissions
- Saskatchewan supplier based out of Regina, Saskatchewan
- This unit met all specifications required in the RFP

The 2023 budgeted amount for this piece of equipment was \$180,000. The highest scoring submission is being recommended.
