



# City of Swift Current DOG LICENSE APPLICATION

1. Every owner of a dog six (6) months old or older shall obtain a license.
2. The dog license year shall be from January 1 to December 31 of the same year.
3. The dog license shall be purchased on or before **February 28** to avoid fines.
4. The license is non-transferable.
5. No person shall be entitled to a license rebate.
6. Only three (3) dogs per residence are allowed.
7. It is the responsibility of every dog owner to notify the City of Swift Current if they no longer require a license.

## ANIMAL RENEWAL NOTICE

To ensure City License fees remain affordable and no increase is required, **changes** have been implemented to the payment policy. Extra costs absorbed in the past in contacting animal owners for information, collecting delinquent fees and the processing of fines have been an issue. *Your response is important* to ensure existing and new animals are registered with the City in time for them to have the proper tags for the current year.

IT IS THE RESPONSIBILITY OF THE OWNER TO CONTACT CITY HALL WITH ANY CHANGES, DELETION OR ADDITIONS TO AVOID FURTHER NOTICES OR VIOLATIONS.

It is also a reminder that if payment is not made prior to **February 29<sup>th</sup>** of the current year, a fine will be issued to the owner of any animal found in violation of this Bylaw No. 1-1991.

- 3 1) The license year shall be from January 1 to December 31 of the same year.
- 2) Every owner of a cat or dog six (6) months old or older shall, "not later than the 15th day of February in each year, or within thirty (30) days of becoming an owner", obtain a license and shall pay therefore an annual fee as set out in Schedule "A" of this Bylaw, said license shall not be transferable to any other cat, dog or other owner. The onus of proof as to the date when the owner actually became the owner of the dog in question shall be on the owner.

\$5.00 - Cost after Deduction if applicable

**TO RECEIVE ANY DISCOUNT YOU WILL BE REQUIRED TO SHOW TRUE DOCUMENTS FOR EACH ANIMAL,**

- VETERINARY PROOF OF SPAYED/NEUTERED (One time only for data base)
- RABIES WILL BE REQUIRED TO BE SHOWN YEARLY(Health requirements)

Any person who contravenes any provision of this Bylaw is guilty of an offence and is liable on summary conviction to a fine of not more than TWO THOUSAND (\$2000.00) DOLLARS.

The levying and payment of any fine shall not relieve a person from the necessity of paying any fees, charges or costs for which he is liable under the provisions of this Bylaw.
